General Notice

The City of Monticello, Iowa (Owner) is requesting Bids for the construction of the following Project:

Monticello Regional Airport

FY25 Pavement Repairs Bids for the construction of the Project will be received at the Monticello City Hall located at 200 East First Street, Monticello, Iowa, until Wednesday, April 9th 2025 at 1:00 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Crack and joint re-sealing, routing and sealing of cracks, pavement spall repairs, full-depth pavement repairs, pavement marking and airfield traffic control.

Bids are requested for the following Contract: FY25 Pavement Repairs

Bidding Documents may be downloaded from the designated website. Prospective Bidders are urged to register with the designated website as a Bidding Documents holder, even if Bidding Documents are obtained from a third-party plan room or source other than the designated website in either electronic or paper format. The designated website will be updated periodically with Addenda, lists of registered Bidding Documents holders, reports on the Site, and other information relevant to submitting a Bid for the Project. All official notifications, Addenda, and other Bidding Documents will be offered only through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including Addenda, if any, obtained from sources other than the designated website.

Prospective Bidders may obtain or examine the Bidding Documents at the Issuing Office on Monday through Friday between the hours of 8:00 AM to 5:00 PM local time and may obtain copies of the Bidding Documents from the Issuing Office as described below. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

Paper copies of the Bidding Documents may be obtained from the Issuing Office by paying a deposit of \$50 for each set. Bidders who return full sets of the Bidding Documents in good condition within 10

days after receipt of Bids will receive a full refund. Non-Bidders, and Bidders who obtain more than one set of the Bidding Documents, will receive a refund of \$25 for documents returned in good condition within the time limit indicated above. Make deposit checks for Bidding Documents payable to City of Monticello, Iowa.

Pre-bid Conference

A pre-bid conference for the Project will be held on Friday, March 28th 2025 at 1:00 PM local time at Monticello Regional Airport. Attendance at the pre-bid conference is encouraged but not required.

Statutory Regulations

The City of Monticello, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit Bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The City of Monticello has established a DBE contract goal for this contract. The Bidder shall make good faith efforts, as defined in Appendix A, 49 CFR Part 26, to subcontract 3.0 percent of the dollar value of the prime contract to certified DBE firms as defined in 49 CFR Part 26. Refer to the Instructions to Bidders for more detailed information. A Bidder must complete and submit the Buy America certification included herein with their Bid.

The Owner will reject as nonresponsive any Bid that does not include a completed Certificate of Buy American Compliance.

This project is funded in part by the Airport Improvement Program, Grant No. 3-19-0061-014-2025 and is subject to the Federal contract provisions described in Specification Section 00 73 73 Contract Provision for Airport Improvement Program Projects.

Bid Security

Each Bidder shall accompany its Bid with bid security as defined in Iowa Code Section 26.8, as security that the successful Bidder will enter into a Contract for the work Bid upon and will furnish after the award of Contract a corporate Surety Bond, in a form acceptable to the City of Monticello, for the faithful performance of the Contract, in an amount equal to one hundred percent (100%) of the amount of the Contract. The Bidder's security shall be in the amount fixed in the Instructions to Bidders and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a Bid Bond on the form provided in the Contract Documents with corporate Surety satisfactory to the City of Monticello. The Bid shall contain no condition except as provided in the specifications.

The City of Monticello reserves the right to defer acceptance of any Bid for a period of thirty (30) calendar days after receipt of Bids and no Bid may be withdrawn during this period. The City of Monticello does hereby reserve the right to reject any or all Bids, to waive informalities, and to enter into such contract, or contracts, as it shall deem to be in the best interest of the City.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.
